Shareholders who are Depositors and whose securities accounts with The Central Depository (Pte) Limited are credited with QAF shares as at the Record Date will be entitled to the FY2023 Final Dividend on the basis of the QAF shares standing to the credit of their securities accounts as at the Record Date.

In respect of shareholders who are not Depositors, duly completed and stamped registrable transfers received by the Company’s Registrar, Tricor Barbinder Share Registration Services, at 9 Raffles Place, #26-01 Republic Plaza Tower 1, Singapore 048619 up to the Record Date will be registered to determine such shareholders’ entitlements to the FY2023 Final Dividend.

Payment of the FY2023 Final Dividend is subject to shareholders’ approval being obtained at the Annual General Meeting of the Company to be held on 26 April 2024. If approved by shareholders, the FY2023 Final Dividend payment date will be 23 May 2024.
